We collect and use your personal information as you are applying to enter a contract with us. We will process special category data to monitor recruitment statistics and make reasonable adjustments to support you during the application process where requested.

If you are successful in your application, your recruitment information will be used to establish your staff record and the Privacy Notice for staff will inform you about how we use your information.

Your personal information will be used for the following purposes:

- Managing the application and recruitment processes
- Communication purposes for example to invite you to interview
- Making reasonable adjustments for candidates with a disability
- Making a decision about your recruitment/appointment
- Determining the terms on which you work for us, if appointed
- Checking that you are legally entitled to work in the UK
- Assessing qualifications
- Requesting references from your previous employer(s), if appointed
- Maintaining recruitment statistics
- Conducting surveys to measure satisfaction for service improvement purposes

Transfers

Personal data may be transferred out of the UK by contracted third parties where there is a lawful basis to do so.

The processing of your personal data does not involve automated decision making.

Your personal information will be retained for the following length of time:

When applying for a job with The Promise Scotland Ltd, you may be asked to provide the following types of personal information:

- Your name, address and contact details, including personal email address and telephone number
- Date of birth, gender
- Details of your qualifications, skills, experience and employment history
- CV, cover letter
- Whether you have a disability or additional needs for which the organisation needs to make reasonable adjustments during the recruitment process
- Information about care experienced status where you choose to provide this information

Where successful at interview, we will also collect:

- References from previous employers
- Next of kin and emergency contact information
- National Insurance number
- Bank account details, payroll records and tax status information
- Salary, annual leave, pension and information about your current level of remuneration, including benefit entitlements
- Workplace location
- Photograph for identification purposes
- Start and end dates
- Copy of driving licence, passport or utility bill
- Information about your entitlement to work in the UK

We may also process special category 'sensitive' data for example:

• Health and disability data where you choose to provide it may be processed to ensure reasonable adjustments can be made during your interview
